

adidas Sneaker Sweepstakes Celebrating Toy Story 5 Official Rules

No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

1. **Eligibility:** The adidas Sneaker Sweepstakes Celebrating Toy Story 5 (the “Sweepstakes”) is open only to legal residents of the United States who are at least 13 years of age at the time of entry and who are members of the Foot Locker FLX Program in good standing. Participants under the age of eighteen (18) years (or the age of majority in their jurisdiction of legal residence) must have the permission of their parent or legal guardian to participate. Employees of Foot Locker Retail, Inc. (“Sponsor”), Walt Disney Studios Motions Pictures (“Disney”) as well as their immediate family (spouse, parents, siblings, and children) and household members of those employees, are not eligible to enter. Membership to the FLX Rewards Program is free and subject to the FLX Rewards Program [Terms and Conditions](#). The Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

2. **Entry Period:** The Sweepstakes begins at 12:00 AM ET June 6th, 2026 and ends at 11:59 PM ET on July 6th, 2026 (“Entry Period”). Entries submitted before or after the Entry Period will not be eligible. Sponsor’s computer is the official time-keeping device for the Sweepstakes.

3. **How to Enter:** There are two (2) ways to enter:
 - a. **By Using Points:** Visit any Foot Locker Inc. banner website and log into your FLX Program account to access this Sweepstakes. Follow the instructions to redeem 1,000 points for one (1) entry. Mark the check box after reading the Official Rules. Once your points are redeemed for an entry into this Sweepstakes, the points will automatically be removed from your account.

OR

b. **By Mail:** Neatly print your first and last name, mailing address, email address, and telephone number along with the adidas Sneaker Sweepstakes Celebrating Toy Story 5 on a 3 X 5 postcard. Please mail to adidas Sneaker Sweepstakes Celebrating Toy Story 5, Attn: FLX Program, 1 Pennsylvania Plaza, Suite 3200 New York, NY 10119. Entries must be postmarked during the Entry Period and received before the drawing date. Entries received after the drawing date will not be acknowledged.

For all Entries: There is a limit of five hundred (500) entries per person, regardless of method of entry. Violation of entry limit will result in disqualification of all entries. By entering, you indicate your full agreement to these Official Rules and Sponsor’s decisions regarding the Sweepstakes, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.

4. **Drawing:** On or around July 10th, 2026, Sponsor, or a third party designated by Sponsor, will select one (1) potential winner (“Winner”) in a random drawing of all entries received. The odds of being selected depend on the number of entries received. Sponsor will attempt to contact the winner(s) via email or text message within five (5) days of the drawing. If a potential winner does not respond within three (3) days after Sponsor’s notification, Sponsor will select an alternate potential winner in his/her place at random from all remaining entries received.
5. **Potential Winner Requirements:** Except where prohibited, a potential winner may be required to complete and return a declaration of eligibility and liability/publicity release. If a potential winner fails to sign and return these documents within the required time period, and time permits, an alternate potential winner may be selected in his/her place in a random drawing of all remaining entries received. Sponsor will attempt to contact a maximum of three (3) alternate potential winners.
6. **Prize:** One (1) winner will win a prize bundle containing: (a) one (1) adidas Samba Jane (Approximate Retail Value (ARV) is \$80.00); (b) one (1) adidas Samba OG Toy Story (ARV is \$80.00), and; (c) one (1) adidas Adistar Central 5 (ARV is \$81.00). Total ARV for the prize is \$241.00. Sizing and color choices are limited to availability. Winner is responsible for paying any applicable income taxes and all other costs and expenses not listed above. Prize details not specified above will be determined by Sponsor, in its sole discretion. A prize may not be transferred prior to award and must be accepted as awarded. A winner may not request cash or a substitute prize; however, Sponsor reserves the right to substitute a prize with another prize of equal or greater value if the advertised prize is not available for any reason, as determined by Sponsor, in its sole discretion.
7. **General Conditions:** In the event that the operation, security, or administration of the Sweepstakes is impaired in any way, Sponsor may, in its sole discretion, either: (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes; or (b) award the prize at random from among the eligible entries received up to the time of the impairment. Sponsor reserves the right, in its sole discretion, to disqualify and seek damages from any individual who tampers with the operation of the Sweepstakes, violates these Official Rules, or acts in a disruptive or unsportsmanlike manner. Sponsor’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Proof of sending any communication to Sponsor by mail shall not be deemed proof of receipt of that communication.
8. **Privacy and Publicity:** Any information you submit as part of the Sweepstakes will be used in accordance with Sponsor’s [Privacy Statement](#). Except where prohibited, participation in the Sweepstakes constitutes your consent to Sponsor’s use of your name, likeness, voice, opinions,

biographical information, state of residence, and any posts you make with the #BornToFLX hashtag for promotional purposes in any media without further payment or consideration.

9. **Release and Limitations of Liability:** By entering, you agree to release and hold harmless Sponsor, Disney and their respective parents, subsidiaries, affiliates, and advertising and Sweepstakes agencies, and each of their respective officers, directors, employees, and agents (collectively, the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of any prize, including, but not limited to (a) unauthorized human intervention in the Sweepstakes; (b) technical errors related to computers, servers, providers, or telephone or network lines; (c) any errors on the social media platforms that may prevent an individual from participating or receiving direct messages; (d) printing errors; (e) lost, late, postage-due, misdirected, or undeliverable mail; (f) errors in the administration of the Sweepstakes or the processing of posts; or (g) injury or damage to persons or property. You further agree that in any cause of action, in no event shall the Released Parties be liable for attorneys' fees or other legal costs. You waive the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

10. **Disputes:** You agree that any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in New York. All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, your rights and obligations, or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of New York, without giving effect to any choice of law or conflict of law rules (whether of New York or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than New York. Moreover, any and all disputes, claims and causes of action arising out of or connected with the intellectual property of Disney shall be resolved individually, without resort to any form of class action, shall be governed and construed in accordance with the laws of the state of California and in the event of any dispute, all entrants irrevocably consent to the jurisdiction of the state and federal courts located in Los Angeles, California to resolve such disputes.
