## **Ultimate Soccer Trip Sweepstakes Official Rules**

## No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

- Eligibility: The Ultimate Soccer Trip Sweepstakes (the "Sweepstakes") is open only to legal residents of the United States who are members of the Foot Locker FLX Program in good standing and who are twenty one (21) years of age or older as of the date of entry. Employees of Foot Locker Retail, Inc. ("Sponsor"), as well as the immediate family (spouse, parents, siblings, and children) and household members of those employees, are not eligible to enter.

  - a. **Using Points:** Visit any Foot Locker, Inc. banner and log into your FLX Program account to access this Sweepstakes. Follow the instructions to redeem 1,000 points for one (1) entry. Mark the check box after reading the Official Rules. Once your points are redeemed for an entry into this Sweepstakes, the points will automatically be removed from your account.
  - b. **By Mail:** Neatly print your first and last name, mailing address, e-mail address, and telephone number along with "FLX Rewards x Ultimate Soccer Trip Sweepstakes" on a 3 X 5 postcard. Entries must be postmarked during the Entry Period and received before the drawing date. Entries received after the drawing date will not be acknowledged.

**For all Entries:** There is a limit of two hundred (200) entries per person, regardless of method of entry. Violation of entry limit will result in disqualification of all entries. Release and Limitations of Liability: By entering, you agree to release and hold harmless Sponsor, Alliance and Melia, and their respective parents, subsidiaries, affiliates, and advertising and Sweepstakes agencies, and each of their respective officers, directors, employees, and agents (collectively, the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of any prize, including, but not limited to (a) unauthorized human intervention in the Sweepstakes; (b) technical errors related to computers, servers, providers, or telephone or network lines; (c) any errors on the social media platforms that may prevent an individual from participating or receiving direct messages; (d) printing errors; (e) lost, late, postage-due, misdirected, or undeliverable mail; (f) errors in the administration of the Sweepstakes or the processing of posts; or (g) injury or damage to persons or property. You further agree that in any cause of action, in no event shall the Released Parties be liable for attorneys' fees or other legal costs. Disputes: You agree that any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in New York.
