## Winter Getaway Sweepstakes Official Rules

## No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

- 1. **Eligibility**: The Winter Getaway Sweepstakes (the "Sweepstakes") is open only to legal residents of the United States who are members of the Foot Locker FLX Program in good standing. Employees of Foot Locker Retail, Inc. ("Sponsor"), as well as the immediate family (spouse, parents, siblings, and children) and household members of those employees, are not eligible to enter.

  - b. **By Mail:** Neatly print your first and last name, mailing address, email address, and telephone number along with "FLX Rewards x Dreams Sapphire Resort & Spa Vacation Sweepstakes" on a 3 X 5 postcard. Please mail to FLX Rewards x Dreams Sapphire Resort & Spa Vacation Sweepstakes, Attn: FLX Program, 330 W. 34<sup>th</sup> Street New York NY 10001. Entries must be postmarked during the Entry Period and received before the drawing date. Entries received after the drawing date will not beacknowledged.

**For all Entries:** There is a limit of two hundred (200) entries per person, regardless of method of entry. Violation of entry limit will result in disqualification of all entries. You further agree that in any cause of action, in no event shall the Released Parties be liable for attorneys' fees or other legal costs.
