

# **Dolphins NRL Experience: Promotion Terms and Conditions and Liability & Content Waiver and Participation Agreement - 2026**

## **PROMOTION TERMS AND CONDITIONS**

### **Overview**

1. This document contains the terms and conditions of entry ("Terms") related to the promotion marketed as "WIN THE ULTIMATE NRL EXPERIENCE FOR YOU AND A FRIEND: WARRIORS VS DOLPHINS", "THE ULTIMATE NRL EXPERIENCE", "FOOT LOCKER x REDCLIFFE DOLPHINS PROMO" and other naming variations (the "Promotion") in Australia and New Zealand. By participating, entrants agree to be bound by these Terms. Entries must comply with these Terms to be valid.

### **The Promoter**

2. The Promoter is Foot Locker Australia Holdings, LLC ABN # 53 669 762 387 of Level 2, 16 Terrace Place Murarrie; its associated business entities in New Zealand; and its in-store associates who act on behalf of the Promoter during the promotion period (the "Promoter"). ### **Promotion Period**

3. The Promotion commences at 9am (AEST) on Monday 8<sup>th</sup> June, 2026 and ends at 11:59pm (AEST) on Friday 18<sup>th</sup> June, 2026, with the winner experience occurring on June 27<sup>th</sup>, 2026 with surrounding travel dates subject to the winners location (the "Promotional Period").

### **Eligibility to Enter**

4. Entry is open to all Foot Locker customers of all ages ("Eligible Entrants"). Entrants under the age of 16 years must obtain consent from their parent or guardian to enter. If a winner is under the age of 18 years, then the Promoter reserves the right in its absolute discretion to award the prize to the winner's parent or guardian and to require that the parent or guardian execute such acknowledgment, indemnity and release as reasonably required in the circumstances.

5. Directors, management, employees and their immediate families, of the Promoter, suppliers, associated entities and agencies associated with this Promotion are ineligible to enter.

6. Participants must only register in their own name and only once per purchase. Any entries of a participant who is deemed by the Promoter to have provided incorrect,

misleading or fraudulent information may, at the sole discretion of the Promoter, be deemed invalid.

7. The Promoter may require participants to promptly provide identification including (without limitation) proof of identity, valid passport, proof of age and proof of residency.

8. The Promoter reserves the right to disqualify any person whose participation is not in accordance with these Terms or who interferes with the Promotion. The Promoter also reserves the right, at any time and at its sole discretion, to cancel, terminate, modify or suspend the Promotion or amend these Terms, subject to any written directions from a relevant regulatory authority. Any changes will be communicated in a manner deemed appropriate by the Promoter.

### **How to Enter & How to Claim**

9. To enter, Eligible Entrants must attend any Foot Locker store in Australia or New Zealand, make a product purchase of any amount, scan the QR code on the promotion material found at point of purchase zones, complete the online form and answer all questions in full including the game of skill question.

10. An individual can only win once. Competition mechanics may vary.

11. The winner(s) of the Promotion will be notified by a representative of the Promoter via methods including but not limited to phone, email, or direct message, on Friday July 18<sup>th</sup> 2026 . The Promoter reserves the right to request proof of identity, residency and eligibility before confirming the award of any prize. If for any reason a winner does not respond or accept the prize within 48 hours of being contacted by the Promoter, or is deemed ineligible, the Promoter reserves the right, at its sole discretion, to conduct a redraw to determine an alternative winner. The redraw may occur at a time and place determined by the Promoter, and any alternative winner will be notified in accordance with this winner notification clause.

### **Prizes**

12. The prize for the main winner (“Winner”) consists of:

- corporate box ticket for the winner and a nominated friend to Dolphins vs Warriors on June 27 2026 (x2 tickets total)
- food and drink package as part of corporate box experience
- match day pre-game experience for winner and nominated friend
- return economy flights for winner and a friend (seats, airlines and timings at the discretion of the Promoter)
- a \$200 AUD Uber voucher for the Winner
- 2 x \$250 Foot Locker vouchers for the Winner

At the Promoter’s discretion a runner-up prize (“Runner Up”) will also be awarded to a second participant which will consist of:

17. Entrants consent to marketing use of their information.

### **LIABILITY WAIVER**

24. By entering the competition the participant you (the "Entrant") confirm that you have read, understood, and agree to be legally bound by the terms of this Promotional Terms and Conditions, Liability Waiver and Participation agreement.

25. Nature of the Prize: The Prize is a recreational service for the purposes of applicable civil liability legislation. Participation is voluntary.

26. Fitness to Participate: You confirm that you are physically fit to participate and have disclosed any condition that may affect your safe participation.

27. Acknowledgement of Risk: You acknowledge that participation involves inherent risks, including injury or death. These risks may arise from running in public and private areas, including underground environments.

28. Safety Obligations: You agree to follow all reasonable instructions and take reasonable care for your own safety and others.

29. Medical Responsibility: You are responsible for your own medical and related costs except where caused by Foot Locker's negligence or as required by law.

30. Release of Liability: To the extent permitted by law, including the Australian Consumer Law, you release Foot Locker from liability arising from your participation in the Event. This does not apply to liability that cannot be excluded by law, including certain liability for personal injury or death.

31. Indemnity: You agree to indemnify Foot Locker for any loss or damage caused by your reckless or unlawful conduct.

32. Individual Acceptance: Each participant must individually accept this waiver. You may not accept on behalf of another adult participant.

33. Age and Understanding: Participants must be at least 16 years old to participate in the Event.

34. Privacy: Personal information will be handled in accordance with the Privacy Act 1988 (Cth) and Foot Locker's Privacy Policy.

35. Governing Law: This agreement is governed by the laws of Queensland, Australia.
