

**Summer Jam 'Golden Jam' Golden Token  
Promotion Terms and Conditions - 2026**

1. This document contains the terms and conditions of entry ("Terms") related to the promotion marketed as "SUMMER JAM - GOLDEN JAM TOKEN" promotion and other deviations of the naming conventions (the "Promotion") in Australia and New Zealand. By participating, entrants agree to be bound by these Terms. Entries must comply with these Terms to be valid.

**The Promoter**

2. The Promoter is Foot Locker Australia Holdings, LLC ABN # 53 669 762 387 of Level 2, 16 Terrace Place Murarrie; its associated business entities in New Zealand; and its in store associates who act on behalf of the Promoter during the promotion period (the "Promoter"). 3. The Promotion commence at 9am (AEST) on January 7<sup>th</sup>, 2026 and ends at 11:59pm (AEST) on Feb 22<sup>nd</sup>, 2026 (the "Promotional Period").

**Eligibility to enter**

4. Entry is open to Foot Locker customers of all ages who are residents of Australia ("Eligible Entrants"). Entrants under the age of 18 years must obtain consent from their parent or guardian to enter. If a winner is under the age of 18 years, then the Promoter reserves the right in its absolute discretion to award the prize to the winner's parent or guardian and to require that the parent or guardian execute such acknowledgment, indemnity and release as reasonably required in the circumstances.

5. Directors, management, employees and their immediate families, of the Promoter, suppliers, associated entities and agencies associated with this Promotion are ineligible to enter.

6. Participants must only register in their own name and only once per store purchase. Any entries of a participant who is deemed by the Promoter to have provided incorrect, misleading or fraudulent information may, at the sole discretion of the Promoter, be deemed invalid.

7. The Promoter may require participants to promptly provide identification including (without limitation) proof of identity, proof of age, proof of purchase, proof of passport, proof of travel insurance and proof of residency (to the Promoter's satisfaction, at its sole discretion) in order to confirm the participant's identity, age, residential address, eligibility to enter, participate and claim a prize.

The Promoter reserves the right to disqualify any person whose participation is not in accordance with these Terms, or who is involved in any way in interfering or tampering with the conduct of this Promotion, has breached any of these Terms, or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion.

9. The Promoter also reserves the right to disqualify any persons who engage in inappropriate behaviour, regardless of whether such behaviour is directed towards other persons at the Store or at the Promoter's employees. Foot Locker.

10. **To qualify for entry**, Eligible Entrants must, during the Promotion Period, purchase any Nike or Jordan product to the value of \$50 or more in a single transaction at participating Foot Locker stores to receive one (1) Golden Jam Token.

11. Only 50 tokens are available per participating city, tokens are distributed on a first come first serve basis after the announcement post on Summer Jam and/or Foot Locker Australia Instagram channels, while stock lasts.

12. An individual can only enter once per purchase, and a limit of one entry applies per person per purchase. A draw is defined as each time a winner is selected.

13. Please note that the competition is subject to be altered, and mechanics vary by country or state.

#### **14. To redeem a token at Foot Locker (whilst stock lasts):**

Purchase \$50 of Nike or Jordan product at the counter

Show Summer Jam Gold Token post on @summerjamau Instagram to the Foot Locker customer service staff member

Receive a Gold Token in a plastic pocket with a QR code on the back

Scan the QR code and follow the prompts to claim your DIGITAL JAM TOKEN TICKET required for redeeming meet and greet and free merchandises prizes

#### **15. To redeem prize entitlements at Summer Jam Events:**

Present your digital Golden Jam Token ticket at the communicated designated redemption point at the event to receive exclusive merch and wristband for meet and greet with Cam Wilder.

Note, you may be required to show proof of purchase and ID to verify eligibility.

Note, tokens themselves are NOT redeemable; digital ticket is required.

Note, Digital ticket must be physically presented; no screenshot or photo accepted.

## **Prizes**

16. Prize for the Promotion (“Prize”) redeemed through valid Golden Tokens consist of a meet and greet experience with Cam Wilder and Exclusive Summer Jam merchandise (one item per token, items subject to availability) which will be organised with the selected individual (“The Winner”). The Promoter and its associated partners reserve the right to alter prizes at any time. Transport and accommodation facilitation is at the sole discretion of The Winner. Limitation include: One token per qualifying transaction; tokens and digital tickets cannot be replaced if lost, stolen, damaged, or destroyed; Tokens are not redeemable for cash, credit, gifts, or other merchandise; Tokens and digital ticket only valid for the event date and location stated.

17. The following terms and conditions apply to any Gift Card components of the prize or any gift cards issued as additional prizes or make-good items: (i) The gift card has no value until activated in-store at one of the Promoter’s stores. (ii) The gift card cannot be used online or in another country. (iii) The Promoter accepts no responsibility for the range of stock available when redemptions are made, including but not limited to brands, styles and sizes. ## **Travel Responsibilities and Ancillary Costs**

the Promoter; (d) any variation in prize value to that stated in these Terms; (e) any tax liability incurred by a winner or Eligible Entrant; or (f) taking and/or use of a Prize.
