

# TERMS AND CONDITIONS ("T&C") JW STUDIOS – HANDBALL SPEZIAL GIVEAWAY

#### 1. SPONSOR

The Competition is sponsored by Foot Locker Europe B.V., having its registered office at Stationplein 32, 3511 ED Utrecht The Netherlands, VAT no. NL800774115B01, registered at the Chamber of Commerce under no. 23067735, hereinafter referred to as "**Sponsor**" or "**Foot Locker**".

#### 2. ELIGIBILITY

Employees of the Sponsor and its partners in this Competition and any of their subsidiaries, agents or any other business involved with the administration of this Competition, as well as their family members are not eligible to participate. The Competition is open only to legal residents of the European countries, UK, and Switzerland where the Sponsor operates and have the legal age to enter the Competition.

#### 3. FRAUDULENT USER

The Competition is addressed only to end users who use the prize for their own use and do not resell it. Foot Locker reserves the right to refuse participation in the Competition to other retailers or bulk buyers. A user may be flagged as "fraudulent" when multiple reservations under different email addresses and/or names have been made by the same user. This status will prevent the fraudulent user from winning any reservations.

#### 4. HOW TO ENTER

Visit and follow the official social media account of the Sponsors @FootLockerEU. Follow the instructions provided to enter the Competition. The participant will have to follow the Sponsor pages, like the competition post, and comment a blue emoji. @footlockereu will randomly select a winner amongst the DMs received with the correct answer. Sponsor reserves the right to request at any time the proof of registration on the social media; the registration shall take place prior the starting date of the Competition. In case such proof is not provided or does not comply with the requirements of these T&C, the participant or the winner will be excluded.

# 5. ENTRY PERIOD

The Competition begins at Nov 17th CET on 17/11/2025 and ends at 23:59 CET on 24/11/2025 ("Entry Period"). Entries submitted before or after the Entry Period or entries not complete will not be eligible. The time added to the database entry is the official time-keeping device for the Competition. By entering, you indicate your full agreement to these T&C and Sponsor's decisions regarding the Competition, which are final and binding.

# 6. DRAWING

On or about 24/11/2025, Sponsor will draw one (1) potential winner with a random drawing generator regulated by a software of all entries received. The odds of being selected depend on the number of entries received. The decision of the Sponsor is final and binding on all entrants. Sponsor will attempt to contact the winner(s) via email / direct message / comment by the official Foot Locker's social media account within one (1) working day after the drawing. If a winner does not respond within two (2) days, the Sponsor has the right to repeat the drawing to choose a new winner.

#### 7. PRIZE

The winner will win one pair of Jw Studios Handball Spezials. Sponsor is responsible for paying the gambling tax, if required. Prize details not specified above will be determined by Sponsor, in its sole discretion. A prize may not be transferred prior to award and must be accepted as awarded. # 8. GENERAL CONDITIONS

In the event that the operation, security, or administration of the Competition is impaired in any way, Sponsor may, in its sole discretion, either: (a) suspend the Competition to address the impairment and then resume the Competition; or (b) award the prize through a random raffle from among the eligible entries received up to the time of the impairment. Sponsor reserves the right, in its sole discretion, to disqualify and seek damages from any individual who tampers with the operation of the Competition, violates these T&C, or acts in a disruptive or unsportsmanlike manner.

#### 9. PERSONAL DATA

Any information you submit as part of the Competition will be used in accordance with Sponsor's Privacy Statement, available on Foot Locker's website. The processing of your personal data is necessary for the performance of the contract with you in order to process your participation in the Competition. Lack of provision of the required personal data means that you cannot participate in the Competition. Sponsor shall only transfer or grant access to your personal data to affiliated companies and/or third parties to the extent that this is necessary for the execution of this Competition. # 10. COPYRIGHTS

You shall respect copyrights. Content cannot include or endorse other brands, trademarks, or commercial establishments. Pornographic or sexually explicit content is not allowed. Foot Locker may withdraw, edit or delete any entry that in the sole judgment of Foot Locker violates these T&C, or which may be offensive, illegal or violates the rights of any person, or in any way brings the submission process or Foot Locker's brand name into disrepute.

# 11. RELEASE AND LIMITATIONS OF LIABILITY

By entering, you agree to release and hold harmless to the maximum extent permitted by Dutch law, Sponsor, its parents, subsidiaries, affiliates, and advertising and Competition agencies, and each of their respective officers, directors, employees, and agents (collectively, the "Released Parties") from and against any claim or cause of action arising out of participation in the Competition or receipt or use of any prize in connection, but not limited, to (a) unauthorized human intervention in the Competition; (b) technical errors related to computers, servers, providers, or telephone or network lines; (c) any errors on the social media platforms that may prevent an individual from participating or receiving direct messages; (d) printing errors; (e) lost, late, postage-due, misdirected, or undeliverable mail; (f) errors in the administration of the Competition or the processing of posts; or (g) injury or damage to persons or property. You further agree that in any cause of action, in no event shall the Released Parties be liable for attorneys' fees or other legal costs. In relation to the above, you waive as of now the right to claim any damages whatsoever, including, but not limited to, direct or indirect damages.

# 12. MISCELLANEOUS

In the event of an obvious error in these T&C, illegality, or circumstances beyond the reasonable control of the Sponsor which prevent the administration of the Competition, the Sponsor reserves the right to amend these T&C or withdraw the Competition. The Sponsor will not be liable for any form of loss or disappointment caused by the same. In such circumstances the Sponsor will make all reasonable endeavors to advise entrants of any changes or withdrawal.

# 13. DISPUTES

You agree that any and all disputes, claims and causes of action arising out of, or connected with, the Competition or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the competent court located in Utrecht, The Netherlands. All issues and questions concerning the construction, validity, interpretation, and enforceability of these T&C, your rights and obligations, or the rights and obligations of the Sponsor in connection with the Competition, shall be governed by, and construed in accordance with, the laws of The Netherlands.
