adidas Messi Signed Jersey Sweepstakes Official Rules

No Purchase Necessary to Enter or Win. A Purchase Will Not Increase Your Chances of Winning.

 - b. **By Mail:** Neatly print your first and last name, mailing address, email address, and telephone number along with the adidas Messi Signed Jersey Sweepstakes on a 3 X 5 postcard.
